Judith Fox, ND Law School

Judith Fox is a clinical professor of law at the Notre Dame Law School, where she teaches and practices consumer law. Since joining the Notre Dame faculty in 1997, she has taught courses in consumer law, alternative dispute resolution, ethics, and domestic violence. Prior to joining the law school faculty, Fox was the deputy director of Berrien County Legal Services in St. Joseph, Michigan. Fox graduated from Notre Dame Law School magna cum laude in 1993. Fox runs the Economic Justice Clinic. Her advocacy and research focus on issues of predatory lending, primarily in the housing market. She is on the Consumer Financial Protection Bureau Consumer Advisory Board and the Advisory Board of the Indiana Foreclosure Legal Assistance Program, the predatory lending committee of the Bridges Out of Poverty Initiative and the National Association of Consumer Lawyers.
